The DFG Document Library is an online repository of thousands of documents pertinent to the department and its customers. Documents can be located by searching for a word or phrase contained within the text of the document or in its associated "cover sheet." An advanced search function also makes it possible to search more specifically by title, author, subject, keywords, date ranges and document categories. Results are initially displayed and ordered by search relevance, but can be sorted in other ways. Once a document has been located, you may view it online or download it to your local computer.
