Kerry, Lieberman to Roll Out Comprehensive Climate and Energy Legislation

WASHINGTON, D.C. – Senators John Kerry (D-Mass.), Chairman of the Foreign Relations Committee, and Joe Lieberman (I-Conn.), Chairman of the Homeland Security and Governmental Affairs Committee, tomorrow will roll out their comprehensive energy and climate change legislation that will create jobs, strengthen America's energy independence, safeguard our national security, and restore our global economic leadership for decades to come.
